

Bio-Vision Limited (In Liquidation)

Liquidators First Report

26 September 2007

1. Background

Pursuant to section 241 of the Companies Act 1993 the above named company was put into Liquidation by the appointment of a Liquidator.

Robert James Neilson was appointed, along with Thomas Lee Rodewald as Joint Liquidator of the company by order of the High Court at Rotorua dated the 6th day of August 2007, at 11.06am.

The Liquidation commenced on the 6th of August 2007. We detail below the Liquidators first report, for the information of creditors of the company.

4. Events leading to appointment of Liquidators

The company struck financial difficulty after injecting funds into another company and received no return on the investment. This coupled with a lack of work, and payments due to the Inland Revenue Department caused the winding down of the business. The director sold the company's assets to try and keep the business afloat, but was unsuccessful. The director then decided to cease trading.

5. Statement of Affairs

We attach as *Appendix I* a statement of the company's affairs as at the date of our appointment. But as we have been unable to obtain any current information it is effectively a nil statement. The only figures we have available are for the year ending March 2005 which are two years out of date and therefore meaningless today.

6. Proposals for Conducting the Liquidation

We are currently waiting for the delivery of the company's records. Once these have been received, we will conduct an analysis of these records looking to realise any funds from the company. Normal statutory duties will be attended to.

7. Estimated Date of Completion of Liquidation and Notice As To Further Reports

It is not practicable to estimate the date of the completion of the liquidation at this stage.

The Liquidators give notice under section 255(5) of the Companies Act 1993 that no further reports will be issued apart from a final report when the liquidation is completed.

8. Creditors Meeting

No meeting will be held. The Liquidator dispenses with holding a creditors meeting pursuant to section 243 of the Companies Act 1993 as the dividend is expected to be nil or very small.

In accordance with Section 314 of the Companies Act 1993 a creditor or shareholder may request the Liquidators to call a meeting of creditors or shareholders at any time in the course of the Liquidation to vote on a proposal that a Liquidation Committee be appointed to act with the Liquidators. This request must be in writing.

The Liquidators may decline a request by a creditor or a shareholder to call a meeting on the grounds that:

- a) the request is frivolous or vexatious; or
- b) the request was not made in good faith; or
- c) the costs of calling the meeting would be out of proportion to the value of the company's assets.

The decision to decline a request may be reviewed by the Court on the application of any creditor or shareholder.
