- That, for any other reason, it would not be just and equitable to remove the company from the New Zealand register.

Report on the conduct of the Liquidation

1. Comments on Asset Realisation

This company had effectively ceased trading and the assets disposed of some time before the date of liquidation. The company had no recoverable debts owed to it. The Liquidators have attended to all statutory duties placed on them and have investigated the records of the company to establish whether there were any undervalue or voidable preference transactions. They are satisfied that no legal actions are warranted. All funds realised have been distributed in accordance with the provisions of the Seventh Schedule to The Companies Act 1993.
