

Easy Mind Limited (In Liquidation)

Liquidators First Report

17 January 2010

1. Background

On the 8th day of January 2010 at 3.13pm Thomas Lee Rodewald and Robert James Neilson were appointed Joint and several Liquidators of the above company by resolution of the shareholders.

The appointment arose after the company failed to make payments to creditors on Wednesday 6th January 2010 and was unsuccessful in arranging further funding over the next two days.

4. Events leading to appointment of Liquidators

The Directors of the company have advised the reason for the failure of the company is due to a number of contributing factors including the rapid growth of the above named company over the past two years and a change in Ministry of Education funding rules. In addition the Ministry of Education deducted an estimated \$350,000 from the November payment on the basis of prior period over claims. The Ministry claims were disputed by the company's director. Funding was also provided to an associated charitable trust which caused a drain on the companies' cash flow. These factors along with others such as a lack of shareholder equity in the business led to a lack of working capital which forced the directors to put the Company into liquidation on the grounds of inability to pay its creditors when due.

5. Trading

The company operates 23 home based childcare networks throughout New Zealand. The Liquidators decided to continue to provide home based childcare services while the business and assets are sold, contingent to reaching appropriate funding. Negotiations with The Ministry of Education proved difficult and they resisted providing any funding.

Attached as *Appendix I* is a press release issued on Sunday 17 January 2010 which confirms:

- a) The sale of the Central North Island networks
- b) The likely sale of the remainder of the North Island networks within a day.
- c) The closing of the South Island networks.

6. Liquidator Review

The Liquidator will be conducting a further review of the financial transactions over the past two years and the conduct of the directors.

Our early view is that the company failed due to rapid growth without the necessary capital base. It would appear even if funding of the children was received upfront and the November deductions were not made the Company would still have not been in a position to meet its obligations to the IRD and still retain sufficient working capital to trade through to the March funding round.

7. Statement of Affairs

We attach as *Appendix II* a statement of the company's affairs as at 8th January 2010.

This has been prepared from information provided by a director of the company and the Liquidators are not yet in a position to express an opinion on the validity of that information.

Also attached as *Appendix III* is a list of known creditors as at the date of appointment.

8. Proposals for Conducting the Liquidation

Following the realisation of assets an investigation will be conducted of the company's books and records to establish if there are any potentially voidable transactions that require investigation, potential current account issues, any related party transactions and ensure the directors have

complied with the duties and obligations imposed on them under the Companies Act 1993. Debtors of the company will also be pursued.

Once all available funds are collected the Liquidators will make a distribution following the order of priority set out in the 7th Schedule of the Companies Act 1993.

9. Estimated Date of Completion of Liquidation and Notice As To Further Reports

It is not practicable to estimate the date of the completion of the liquidation at this stage. Further reports will be issued six monthly and a final report at the conclusion of the liquidation.

10. Creditors Meeting

A Liquidator may call a meeting of creditors in order to decide whether an application should be made to the Court to appoint a replacement Liquidator.

Having regard to the assets and liabilities of the company, the likely result of the liquidation and other relevant matters, the Liquidators consider in accordance with section 245 of the Companies Act 1993 that no such meeting should be held.

A meeting will not be called unless within 10 working days after receiving this notice a creditor gives notice in writing to the Liquidator requiring a meeting to be called.

The Liquidators dispense with holding a creditors meeting pursuant to Section 243 of the Companies Act 1993 as the dividend is expected to be nil or very small.

In accordance with Section 314 of the Companies Act 1993 a creditor or shareholder may request the Liquidators to call a meeting of creditors or shareholders at any time in the course of the Liquidation to vote on a proposal that a Liquidation Committee be appointed to act with the Liquidators. This request must be in writing.

The Liquidators may decline a request by a creditor or a shareholder to call a meeting on the grounds that:

- a) the request is frivolous or vexatious; or
- b) the request was not made in good faith; or
- c) the costs of calling the meeting would be out of proportion to the value of the company's assets.

The decision to decline a request may be reviewed by the Court on the application of any creditor or shareholder.



Press Release
Issued on 17 January 2010

The Liquidators are pleased to announce over the weekend they have sold the business and assets of the above named company located in Hawkes Bay, Palmerston North, Feilding and Gisborne to Scallywaggs Sprouts In-home Childcare.

The Managing Director of Scallywaggs Martin Ennor has confirmed his company will be offering employment to all current staff, coordinators and educators in those regions.

The Ministry of Education staff confirmed today they will arrange a swift transfer of all necessary licenses.

The Liquidators confirm they are continuing to operate normal services in the Waikato and Coromandel while they negotiate a sale. It is expected a sale will be concluded on Monday.

The Liquidators advised staff & contractors that Easy Mind will cease to provide childcare services at 5.00pm today (Sunday 17 January 2010) in the South Island. The Liquidators are unable to secure the short term cash required to pay staff and educators pending an orderly transition. The Ministry of Education did not consider it appropriate to advance any further funding.

A proposal was placed before the Ministry that the Liquidators considered would allow the Easy Mind Childcare service to continue to operate for three weeks at no net cost to the Government. This was not accepted by the Ministry. The decision seems to be based on concerns over previous company management's financial dealings with the Ministry.

Over the seven days of the liquidation, there has been an estimated cash shortfall of \$75,000. The liquidators have financed part of this amount in the short term to ensure that the staff and contractors are paid. Unfortunately it was not possible to complete a sale of the South Island Easy Mind business and assets within a short timeframe.

The liquidators have been working with the Ministry to ensure the transfer of childcare services to different providers will occur as soon as possible.

The Liquidators and Ministry staff have spent many hours in consultation over the past few days. The Liquidators acknowledge the support of the Ministry staff in this sale process.

- Note 1** The debtor's ledger seems to contain a level of prepayments. It will take several weeks to analyse a correct debtor's value. We have identified the Ministry of Education wash-up payment due as at 8th January 2010 at \$506,250 inclusive of GST.
- Note 2** The Early Childhood Education Trust is an associate entity in that the company directors F & C Grace are Trustees.
The trust has not yet commenced operations as no licence approval has been received for the four centres under development.
The first licence for the five applied for is expected to be issued in March 2010.
- Note 3** The Shareholder Current Account has not been fully reconciled. It is expected any overdrawn balance will be repaid in full.
- Note 4** The Company owns five properties (including one section). One is leased to a third party on commercial terms. Three are currently utilised by the company.
We await valuations to be received.
- Note 5** The Company has office equipment & furniture located throughout New Zealand.
We are awaiting valuations of these assets.
- Note 6** The Company has 33 vehicles located throughout New Zealand.
We await valuations to confirm possible realisations.
- Note 7** The Company has a minor holding of consumable stock at various locations. It is believed realisation from the stock will be minimal.
- Note 8** Work in progress appears to be refurbishment costs under way, plus resource consent costs for Hamilton. These assets will be realised in conjunction with any sale.
- Note 9** Some minor amounts have been lent to Grace related entities.

The Liquidators initial views are that the Book Value of assets substantially exceed the realisable value of those assets
